They are also providing one-on-one counselling supports to students and using google platforms to enable students to join skill building sessions and spend time with their peers.

The FSLWs are working with parents and teachers to create healthy online learning communities and helping families to develop schedules to keep kids active. They are also creating resources such as mini counselling kits, birdhouse making kits, drumming kits, and journals and finding ways to engage with families virtually through activities such as Lego building challenges and yoga.

The Division webpage is updated regularly and provides family resources, social stories, tips for talking to kids about COVID, and information regarding provincial/federal resources, etc.
