4. Adoption of Minutes

Michelle Millington, Division Council Chair, presented the minutes of the Division Council of School Councils' meeting held on [2026 March 12](#) for adoption. A motion was made to adopt the minutes, all in favor.

5. School Council Roles & Governance

Leanne Dulle, Secretary Treasurer, attended the meeting to provide some information to the group on the use of funds from societies and councils.

School Council vs. Parent Fundraising Association (PFA) Roles and Legal Status:

- School councils advise principals and the board on educational matters and student learning support; they are not separate legal entities and operate under the Education Act.
- Fundraising is not the primary purpose of school councils; AGLC activities require a registered society. Councils can hold minimal non-gaming funds in separate accounts but cannot fund staff gifts.
- PFAs are registered societies that raise and manage funds for school needs, can pursue grants requiring legal status, and participate in AGLC casinos/bingos/raffles.
- PFAs may fund teacher gifts if bylaws and AGLC use-of-proceeds permit; changes require application to AGLC.

School Council are for advisory and educational input; use Fundraising Associations are for fundraising within bylaws and AGLC rules.

6. Budget 2026-2027 Spring Budget Release

Leanne Dulle, Secretary Treasurer, provided an overview of the draft budget for the 2026-2027 school year.

- The division is experiencing a sustained enrollment decline, but strong programming is helping reduce the impact and retain students where possible.
- Instruction funding has increased overall, but rising costs and declining enrollment offset gains, leaving the division in a tight but slightly positive funding position.
- Non-instruction areas are experiencing overall funding reductions, with transportation changes creating the biggest operational pressure.
- The division maintains a stable revenue structure, with expenditures well-aligned to funding expectations and restrictions.
- 75% of spending is salaries/benefits - rising wages and benefits outpace funding.
- Division has returned to balanced budgets due to limited reserves.
- Changes are being managed through attrition, not layoffs.
- Complexity Team implementation is underway in elementary; expansion into grades 7-12 pending provincial decisions.

Student Fees

Leanne Dulle, Secretary Treasurer, shared the process of collecting proposed fee changes from schools. Schools submit detailed rationales and itemized costs to ensure consistency in course fees across schools. There are some increases proposed for 2026 –2027.

Changes to Managing Division Information, Access and Privacy

Effective June 11, 2025, Alberta replaced the Freedom of Information and Protection of Privacy (FOIP) Act with two new laws: the *Access to Information Act* and the *Protection of Privacy Act*.
