III. PRESENTATIONS

1. OLC Residencies

Carla Carrier, Director of Learning & Partnerships, explained the residencies, which will concentrate on literacy and numeracy, will last for five weeks. During this school year, the six OLCs will have the opportunity to visit six different schools. OLC's will partner closely with administrators and teachers, bringing professional learning, resource sharing, and collaborative teaching directly into classrooms during an intensive rotation. This structure ensures that learning is practical, aligned with division goals, and responsive to each school's needs. We will share insights into the residency model, early feedback, and how this tailored approach not

only empowers teachers but strengthens cohesion across our system.

Deni Neigum, Principal, Loren McCleve, Teacher, and Jessie Blanchet, Teacher from Connaught School demonstrated how these residencies have improved teaching and learning in their schools by aligning the goals with the specific areas where their school sought support. They shared insights into the residency model, early feedback, and how this tailored approach not only empowered their teachers but strengthened cohesion across our system.

After the administration and teachers had discussed the goals of this residency, it was followed by each classroom having embedded time with the OLC for discussion, help to implement programming, modelling, etc.

Connaught staff agreed that this model is more effective than previous approaches, leading to stronger relationships with the OLC, improved accessibility, and a clear point of contact for follow-up after the residency ends. They noted that the five weeks flew by and suggested that extending the OLC's time in the building would be highly beneficial if feasible.

The OLC is released to help other division schools during the residency when the school has regularly scheduled assemblies, presentations etc. and on Professional Learning Days.
