Teachers and students that went on the trip, presented to the Board on their experiences and educational highlights. In addition to their participation in a volleyball tournament students volunteered cleaning up garbage from the coastline, gardening at a nature preserve in Waimea Valley and planting over 100 trees. Students shared that this experience has made them want to give back to the community on future vacations.

3. English as Additional Language (EAL)

The English as Additional Language (EAL) team works collaboratively with schools and families to support academic programming and serve as a resource to assist families new to Canada with system navigation. Emma, Tylene, and Ayman provided a guided tour of our system EAL profile, the registration and intake process, the described stakeholder challenges, and the strategies to support students and families in these areas. Future team priorities include the ongoing capacity development of staff and finding new ways of connecting with our families to gather feedback, share information, and build relationships.

Originally referred to ESL (English as Second Language) the program name has been updated to EAL (English as Additional Language) as English may not be a second language, but a third, fourth or fifth for some students. Currently there are 42 different languages being spoken in our division. As there are limited members of this team, an important part of their job is capacity building with classroom support teachers, teachers and EAs. These individuals need to feel confident in what they are doing and complete annual training to help this. Some students are provided an alternative EAL report card. This allows the teachers to grade the student where they are at rather than using the division report card.

Cultural support has been identified as an important part of ensuring academic success for these students. Academic, service, transactional and cultural challenges play a part in determining the success of these students. Transactional challenges focus on the major differences between cultures for individuals new to Canada.

Looking ahead, the group is working towards a better understanding of the experiences of others and becoming more responsive and adaptive. Increasing belonging and a sense of connection with everyone. Continuing to develop capacity intercultural competence and developing interpersonal skills that are key to academic success.

Emma is a Mushkegowuk Cree woman from the Chapleau First Nation Reserve in Ontario. Emma is the first ever indigenous woman to wear the Miss World Canada crown. Emma is a fancy dancer, ribbon skirt maker, hunter, goose caller, beader and fisherperson, she encourages youth to find their pathway by taking risks and stepping outside of their comfort zone.

As Emma prepares to represent Canada on the Miss World stage in 2024, she is working with communities to inspire youth to find their passion and chase dreams. The theme of Emma's presentation is to encourage students to expand their boundaries and say yes to positive opportunities. Emma strongly believes that through passion, drive and determination, there is no limit to what people can achieve. Emma also touches on her struggles with anxiety and the pressure of coming from a small town, advocating that regardless of where a person comes from and what their limitations may be, their dreams are always within reach.

Superintended Davidson shared his appreciation for the First Nations, Métis and Inuit team and their efforts in welcoming indigenous people from across the country to share their accomplishments and value as leaders.
