4. What might be some supports students and families may need to make a smooth transition to a new school if amalgamation takes place?

Parents, community members, and school staff were divided into small table groups. Each group had an MHPSD facilitator who recorded responses to each question. The information gathered will be shared with the Board of Trustees.
