## 4. Adoption of Minutes

Gicela Cardona, Division Council Vice-Chair, presented the minutes of the Division Council of School Councils' meeting held on <u>March 13, 2025</u> for adoption. A motion was made by to adopt the minutes, all in favor.

## 5. Close to Home Presentation

Cody Edwards, Associate Superintendent introduced presenters from 'Closer to Home'. The service provider is newly operating in Medicine Hat but established in Calgary and other regions.

The organization is recruiting foster families in Southern Alberta and aims to provide 50 beds for children and families.

Closer to Home supports foster children from diverse backgrounds, ages 0–18, and highlighted the importance of cultural diversity and individualized care.

The presentation included personal testimony about fostering over 35 children in 15 years, emphasizing the impact on both children and foster families.

Information packets (fact sheets, posters, business cards, supervisor contact details) are available and those in attendance are encouraged to share information with their schools to support foster family recruitment.

### 6. Draft Budget 2025-2026 Spring Budget Release

Leanne Dulle, Secretary Treasurer, presented an overview of the draft budget for the 2025-2026 school year. The three key items are enrollment, revenues and expenses.

#### Enrollment

Projected enrollment for 2025-2026 is 6,881 students (a decrease of 156 students from last year), attributed to lower birth rates and a larger outgoing Grade 12 class compared to incoming kindergarten numbers. The division has seen a steady decline in enrollment over the past five years, with most of the reduction occurring in the upcoming year. Enrollment numbers are monitored closely throughout the summer, but final figures are not confirmed until September.

#### Revenues

91% of our budget comes from Alberta Education grants. Base grants constitute about 49% of the total grant profile (approximately \$87 million)

- Base grants did not increase (0% change), despite rising operational costs
- The mental health grant, previously over \$600,000 annually, was reduced by \$347,000 as the provincial pilot program ended and was replaced by a broader but smaller allocation.
- The province changed the funding formula from a 50-30-20 weighted moving average to a 70-30 model. This adjustment is less favorable for divisions with declining enrollment, as it reduces the funding buffer for departing students.
- Other grants saw minor increases (e.g., 2.32%), but these did not offset the lack of increase in base grants.
- The division anticipates a net reduction in instruction grants of about \$1 million, primarily due to fewer students.
- Local revenues (investment income, fundraising, fees) account for \$5.4 million (5.7%), and school-generated funds and fundraising contribute \$2.8 million (3%).

 Declining enrollment directly reduces funding, as grants are tied to student enrollment.

#### Expenses

- Instruction block: 79% of expenditures, matching the proportion of revenue allocated to instruction.
- Operations and maintenance: Approximately 12% of expenses, with recent relief from the elimination of the carbon tax helped to offset rising utility costs.
- Transportation, system administration, and external services comprise the remainder.
- Staffing Costs: salaries and benefits make up about 75% of the budget.
  - Despite a reduction of 7.7 certificated staff (teachers), overall staffing costs are increasing by \$1.4 million due to grid movement, benefit increases, and other factors.
  - Non-certificated staffing: While education assistant (EA) numbers at schools are not being reduced, the exact composition will be finalized after staffing meetings.
  - The Play and Learn program, now licensed, requires eight additional staff to meet regulatory ratios, offsetting some reductions elsewhere.
  - Net staffing change is a reduction of approximately 3.6 full-time equivalents when combining certificated and non-certificated adjustments.
  - Additional expense pressures include increased group benefit costs, sub pay, and specialized staffing for mental health and complexity classroom initiatives.
  - The division is implementing contingency plans due to ongoing negotiations (e.g., ATA settlement and complexity classroom fund), with estimated allocations included in the budget.

The division is focused on achieving a balanced budget for 2025-26, following three years of planned deficits and reserve reductions, however, the lack of increase in base grants, combined with rising costs and declining enrollment, creates significant fiscal pressure.

# **Nutrition Policy**

Cody Edwards, Associate Superintendent of Student Services, introduced Sonja from Alberta Health Services and Sarah, the Division's Health and Wellness Manager. Cody shared an overview of ongoing efforts to enhance nutrition in schools.

As part of this initiative, a survey will be distributed to school council chairs to gather feedback on current food vendors, hot lunch programs, and fundraising practices. The survey aims to collect information on both the challenges and successes related to

offering nutritious food, as well as details about menu offerings and practices such as breakfast programs and special event meals.

The insights gathered will help develop an approved vendor list that aligns with the updated nutrition policy. School councils are encouraged to complete the survey by mid-June.
