Comprehensive school health team continues to invest in the Rethinking Recess initiative with the health champions (for students) and the wellness champions (for staff). They are entering into a research partnership with AHS and have applied for a Wellness Fund Grant which supports wellness projects in schools.

- 3.4 Discussion on Division Council of Councils Election and Meeting There was a request to develop a process for appointing/electing members for positions on the Division Council of Councils along with a process for notifying members and potential members about meeting dates and times.

Appointments/elections usually happen at the first meeting of the new school year, however, without enough advance notice, not everyone wanting to participate in the election process is able to attend.

Notification of the first meeting is sent out to School Councils from the principal of the school.

Suggestion that the appointments/elections for local School Councils occur in May/June so they are on the invite list and can be formally invited to the Division Council meetings, specifically the first one of the new school year.

Mark Davidson will prepare and present a proposal for process and structure of meetings and notifications at a later date.

4. TRUSTEE COMMENTS

4.1 – Budget – Rick Massini

New government budget will have a significant impact on schools. Our school division has a \$2.4M shortfall this year that will be covered by reserve. Next year the shortfall will be \$3.8M. MHPSD will tighten/reduce spending. This can be summed up by having more students every year but no more money. There is a Choice in Education Survey available on the division website. Trustees strongly encourage everyone to read the questions carefully and complete the survey.

4.2 - Family Voice - Carolyn Freeman

MHPSD has developed Teacher Voice and Student Voice to gather questions/concerns from teachers and students. Next the board sees value in developing a process where school communities can share their 'community voice'. This allows questions/concerns to be addressed as well as gives information on what is important to each group to the trustees.

5. POLICY UPDATES AND REVISIONS – Mark Davidson

5.1 - Policy 634 and 808, Banned Substances

Board gave direction in terms of policy and practice in educating students and families and other agencies. hey are working with AHS to build resources that will be available on the division site for teachers.

Changes outlined in policies attached to the meeting agenda.

Definitions are written to be flexible so they can include new substances that come up. Mark will take the definition of "Drugs" back for rewording as it seems to only include certain drugs.

There will be a Fair Notice letter going out to the school communities outlining the changes and consequences of not adhering to the policies.

5.2 - Policy 206 - Regular Board Meetings

6. ANNUAL EDUCATION RESULTS REPORT AND 3 YEAR PLAN – Corey Sadlemeyer

Spring 2020 is the end of the current 3-year plan. The timeline for submitting this document has been extended into 2020 and once that report is complete, it will go to the Board for approval and then to this group. Questions presented were: What are priorities that families/school communities have?

Do we need a special Division Council of Councils meeting to discuss? How to get information out and gather information?

Discussion included suggestions to have a spot on each school website with small facts to get information out, have somewhere parents could comment, having questions pushed through local school councils from the division, having an "open voice" section of each board meeting where people could voice opinions/concerns, inviting trustees to school council meetings.
