2. District Focus Update

Ms. Delanoy provided an update on District assessment work and the three year journey to outcome based assessment. She indicated that moving to an outcome based focus will assist the District in terms of articulating engagement and academic progression. The District is exploring the Power Teacher Pro platform and how it can be optimized at a District and school level and is also doing Portfolio piloting.

The outcome based focus helps students to understand and see evidence of what is to be learned and what the learning process may look like. Additionally students and teachers have a common language around learning, outcomes, toolkits, etc. Outcomes are visible in the classroom, on projects, assessment and instructional processes.

The District will continue working with schools in the areas of instructional development, best practice and assessment.
