1. Teachers' Voice Updates

2. Student Engagement Session Update

Cody Edwards, Associate Superintendent of Student Services, shared some background on the second student engagement session held at central office on Tuesday, December

3. Approximately 30 students joined trustees and executive to share their perspective on

various topics such as learning, Truth and Reconciliation, careers and planning and opportunities available to them. The session involved both individual reflection and group collaboration. Once the student feedback is summarized it will be shared with the Board and school administrators.

3. Policy & Procedure Updates

The committee reviewed the following policies, procedures and exhibits that have been updated or newly drafted.

Jurisdictional, School and Program Review

Tracy Hensel, Superintendent, reviewed the updated administrative procedure drafted to more clearly outline the school review process. The updates to administrative procedure 104 AP 001 began last year. A committee was formed to discuss what a school review process should involve and to gather feedback from schools that had been through this process. Once the administrative procedure was drafted, this committee worked alongside Sharon Allan, consultant from the University of Lethbridge to draft the guideline.

Herald School volunteered to be first to engage in the process in hopes of fine tuning the new documents.

There were positive comments on the process, and the valuable feedback received.

Personal Digital Devices

The education minister has mandated the restriction of cell phone use in schools, with policy to be in place by January 1, 2025. Corey Sadlemyer, Associate Superintendent of Learning, outlined changes to our existing policy, administrative procedure, and the addition of a new exhibit.

All schools already had guidelines in place for technology use, and schools collaborated to ensure consistency among grade levels. The exhibit 608 E 001, not updated but included for reference, is an agreement that should be signed and kept in the student file.

The updated documents have been circulated for input and feedback from schools, students and parents and will be reviewed by the Board of Trustees on December 10, 2024, for formal approval.
