- Adoption of Minutes**

Adoption of the minutes of the Division Council of School Council Meeting held on [May 12, 2022](#). Motion by Joni Hunter to adopt the minutes, Heidi Mack second.

- Treaty Land Acknowledgement**

Chelsey Cowan, past Chair, shared the land acknowledgement.

- Organizational Items**

Mark Davidson opened the election opportunities.

Election of Division Council Chair: Stephanie Williams offered to be the Chairperson. No other names were put forth for Chairperson. Stephanie Williams elected as Chair by acclamation. Motion all in favor.

Election of Division Council Vice-Chair: Karen Saffran agreed let her name stand for Vice-Chairperson. No other names were put forth for Vice-Chair. Karen Saffran elected as Vice-Chair by acclamation. Motion all in favor.

Election of Parent Representative to sit on Coordinating Committee. (Meeting dates: Oct 24, Feb 13, April 3, May 15 from 10:00 a.m. to 12:00 p.m.) The group motioned that Courtney Scott's name be put forth to, once again, attend Coordinating Committee as the parent representative. As Courtney was unable to attend today's meeting, Stephanie Williams or Karen Saffran will stand as secondary. Motion by JJ Kimber, all in favor.

6. Virtual vs. In-Person Meetings

Chair, Stephanie Williams, opened the discussion of preference for holding future meetings virtually or in-person. The group decided that the March 9, 2023 meeting will be virtual, and the May 11, 2023 meeting will be in-person. Motion by Joni Hunter, all in favor.

There were no comments on the updates to the 500 section of policy.

It was noted that the edit to Policy 610 - Inclusive Education indicating 'all including 2SLGBTQ+ families' was an intentional edit to be inclusive.

Updates to policies 610 and 614 were also to improve wording as recommended by Alexandra Marshall from the University of Alberta, who provided a professional development opportunity for our staff regarding 2SLGBTQ+ students and community.

Tracy noted that 612 AP 004 was developed to clarify a process for Administrators to follow.

Motion to accept the updates to both the 500 and 600 section of policy as presented by Joni Hunter. All in favor.

9. Items for Discussion

Alberta School Council Association Funding

The Alberta School Councils' Association was denied government funding, once again, for 2022/23. The ASCA is asking that school councils utilize the Alberta School Council Engagement Grant funds to register in ASCA workshops. Early registration is encouraged.

Mark Davidson reiterated the importance of support for the Alberta School Council Association. The sessions and workshops are very informative.

The group discussed combining engagement grant funds to host a mini conference. JJ Kimber motioned that the schools pool funds to put on a mini conference.

The motion was amended: that the Division Council Chairs will discuss with their school council the idea of potentially combining the Parent Engagement Grant Funds to host a mini conference and report back to Chair Williams. Joni Hunter motioned. All in favor.

Some of our school councils used their 2021-22 Alberta School Council Engagement Grant funding to partner with the Medicine Hat College and the Brandon Niwa Legacy Fund – The Beej Project. Those that attended the sessions provided a brief update to the group.

For the first session related to ages 6 to 11 there were 43 parents/caregivers in attendance and the second session for ages 12 to 18 had 80 parents/caregivers in attendance.

Tracy Hensel indicated that the neurosequential model discussed in the sessions has been part of our divisions work since 2018. The information was a bit clinical for a parent audience and most parents were looking for strategies. There were good discussions with parents following the sessions.

The follow-up sessions in November will be question and answer style. The Medicine Hat College will facilitate gathering questions from those that attended.
