   Now set up per grade level. Uniform and consistent across the system. Similar is beingset up for teacher supply lists for elementary.
- <u>628 E 003 International Students' Fee Schedule DRAFT</u> This is more detailed regarding insurance, airport fees, accommodations, and activities.

Policy (724 was 812) – School and Program Closure and Relocation

This policy and related APs were moved from the 'Facilities' section into the 'Educational Program' section of manual. For the most part the other changes were made to bring the policy into line with the Education Act. Changes to Policy will be brought to the Board for consideration in April.

- <u>Policy 724 School and Program Closure and Relocation DRAFT</u> If Division is closing a school (Note: not happening right now). Just for if/when. There has to be engagement with the public, parents, staff, and the board.
- 724 P 001 School Closure or Grade Relocation DRAFT
- 724 P 002 Program Relocation or Closure DRAFT Has to be engagement with those impacted. The only possible are middle school outreach programs in the next couple years, but they are phasing out anyway. This is a similar process as Connaught when it moved to French only.

Policy 814 – Disposal of Real Property

This policy was also amended to bring it in line with the Education Act. Changes to Policy will be brought to the Board for consideration in April.

 <u>Policy 814 Disposal of Real Property DRAFT</u> Most changes are due to align with the Education Act.

## Budget 2021 Update

Minister Toews announced Budget 2021 on February 25, 2021 which was followed by a meeting with the Education Minister. We expect to hear end of March/ beginning of April. Talked about the province "holding harmless" - because enrolment numbers are skewed due to COVID, we would've had to pay back for prior year, but not looking like the province will have us do that this year. Might get funded for actual #'s. PUF is only ages 3 and 4 years. Lost so many numbers and \$1.1-1.5 million dollars when it changed. Maybe will use extra money from this year to bolster supports for coming years. Jerry Labossiere may provide a draft budget at the next meeting.

# High School Hub

Jason Peters, members of our OLC Team and teachers from our system and others are working to develop quality, asynchronous resources for high school courses; priority is being placed on the development of 'core' courses at this time. Within our system, high school HUB students would view the asynchronous material and then attend scheduled, mandatory tutorials with subject experts throughout a quarter. Working with other school districts in our area as a true cooperative. Should have it ready by end of August. The dash one and dash two streams and maybe some options will be ready. Will provide resources for Coulee Collegiate as well. Following scope and sequence and building in assessments. Working with guidance counsellors as well. ADLC is shutting down so this works well as it incorporates all the high school and distance learning in one.

# **Enrolment Update**

Reminder to parents that registration is now available for 2021-2022 school year. So far, the enrolment numbers are looking good 80-85% gains from last year. Kindergarten enrolment looks normal, grade 10 up nearly 70 students, everywhere else a little soft.
