## I. CALL TO ORDER

# II. OATH OF OFFICE

In accordance with Section 76 of <u>The School Act</u>, every trustee shall take and subscribe to the official oath prescribed by the <u>Oaths of Office Act</u> before commencing the trustee's duties, and shall deposit the oath with the secretary of the board.

# III. TERM OF OFFICE OF CHAIR AND VICE-CHAIR

In accordance with Section 65 (1) of <u>The School Act</u>, the Board is required to elect one of its members as Chair and another one as Vice Chair, as well as specify the term of Office of the Chair and Vice-Chair.

In past years, the Board has set the term of office for the Chair and Vice-Chair to a period of one (1) year.

Circulate ballots (if necessary and count).

Collect and count the ballots.

Announce the new Board Chair.

Meeting is to be turned over to the new Chair.

# 2. <u>ELECTION OF VICE-CHAIR</u>

Call for nominations for the position of Board Vice-Chair:

- Calling once.
- Calling twice.
- Call for a third and final time.

Declaration of a completed slate for the position of Board Vice-Chair.

Circulate ballots.

Collect and count the ballots.

Announce the new Vice-Chair of the Board.
