BACKGROUND

The Alberta Education assurance survey replaced the accountability pillar survey in 2021. Many of the measures overlap with the previous survey and some measures were new (indicated in the summaries).

Surveys were administered to:

- students in grades 4, 7 and 10, students in grades 4-9 in small schools

- parents of students in grades 4, 7 and 10
- all teachers
- some schools chose to over sample.

Each year, these results are used by schools and the school division to develop our assurance plans and school goals found on each school's website.

Commentary and Analysis: The Spring 2024 Overall Summary Report reflects Medicine Hat Public School Division's commitment to shared, research-based instructional focuses and the continued enhancement of supports and services for student success and stakeholder connection and belonging. The observed decline in select results must always be carefully analyzed; still, it is valuable to note that often the regression is relatively minimal, ranging from 0.9 to 1.6 difference. The current Citizenship result (76.9) requires continued attention and is discussed further in a subsequent report area. It is encouraging to note that the Parent Involvement result is above the three-year average and that the overall achievement indicator for Education Quality remains "high". Schools will continue to provide individualized learner pathways throughout a student's education to support the goal of High School Completion.

Commentary and Analysis: Teacher/parent satisfaction results regarding students modeling the characteristics of active citizenship remain relatively stable in 2024. Focusing on the student result of 66.1%, it is worthwhile to note that middle and high school students report lower agreement with the statements "At school, students follow the rules" and "At school, students respect each other". The significant value students place on safe and respectful learning environments is reiterated in multiple evidence sources collected as part of the Assurance Model. MHPSD school leadership teams will continue to have opportunities to share strategies and ideas connected to social-emotional learning, character education, positive behaviour supports, and other areas connected to student citizenship.

Commentary and Analysis: 2024 teacher result suggests staff are confident that students are learning meaningful literacy and numeracy skills. Examining the disaggregated student data, it appears that increased clarity of learner outcomes and the purposeful connection to learning activities will benefit all learners. However, it could be particularly beneficial for gr 4-6 students, where there was a lower result amongst this demographic. In the 24-25 school year, the Optimal Learning Coach (OLC) delivery model will adjust to embed OLCs in schools for an extended time frame through a residency format. It is anticipated that teachers and schools will benefit from responsive and timely support to meet student needs and teacher instructional focus.

High School Completion Rates: How many students complete high school within 3, 4 or 5 years of entering grade 10.

Commentary and Analysis: Schools continue to monitor student progress and offer flexible and creative graduation pathways to support students in meeting High School completion requirements. Division staff dedicate time and resources to programs such as the Registered Apprenticeship Program and optional career-based programming. On page 11 of this report, there is a noted regression in the 3 and 4-year First Nations, Métis, and Inuit High School completion rates and an improved 5-year completion percentage. Working with schools, the FNMI Team, and families, possible variables that may have impacted this measure will be explored and addressed.

Commentary and Analysis: Parent and teacher satisfaction 2024 results with the overall quality of basic education remain “high”. The student result is in the “intermediate” achievement category and will be monitored. In the 2024-25 school year, certain schools will build on the early implementation of school-wide STEM and Arts focuses. Multiple schools are also beginning a new journey with Academies that provide students opportunities to participate in high-interest activities such as hockey, ringette, volleyball, basketball, culinary arts, and more. MHPSD schools strive to ensure all students find their passion, are satisfied with their school experience, and persevere through the challenges they might encounter.

Commentary and Analysis: A significant portion of students at all grade levels report their teachers care about them (Gr. 4-6 – 87%, Gr. 7-9 – 72%, Gr. 10-12 – 76%) and that other students treat them well (Gr. 4-6 – 72%, Gr. 7-9 – 70%, Gr. 10-12 – 82%). A concern for some of our students is the perceived respect and care observed between other students. The school division enters year 2 of a Social-Emotional Learning (SEL) Plan to promote a common SEL language and learning experience for Grades 1 – 8 students. It is expected that with increased staff familiarity and efficacy with program delivery, students’ results in this measure will improve.

Commentary and Analysis: The MHPSD system and school supports perceived to be connected to students' schoolwork are more recognizable to stakeholders than services that assist students with problems not about schoolwork. Success Coaches, Family School Liaison Workers, and other mental health support services have remained consistent over the past four years. Recently, the school division hired a Cultural Liaison Worker to assist newcomer families with system navigation and promote parent/guardian connection with their child(ren)'s school. Analyzing stakeholder feedback and other evidence sources, data is triangulated, thus enabling effective and timely interventions for students. The Continuum of Supports developed by schools will remain a priority by reviewing existing services and creating new strategies to respond to emerging needs.

Commentary and Analysis: It is encouraging to report that in 2024 parent satisfaction with their involvement in decisions about their child's education is the highest in four years. The most significant increase is amongst parents with children in Grades 7 to 9 (2023 – 60.7% statement agreement to 2024 – 68.2% statement agreement). The percentage of agreement also increased for Gr.4 to 6 parents and Gr. 10 to 12 parents compared to the 2023 results. The Parental Involvement measure is regularly discussed at school council meetings and with the division council of council representatives. Home-school collaboration requires ongoing attention and care to promote parental involvement and trust.
