POLICY 812 724: SCHOOL AND PROGRAM CLOSURE AND RELOCATION

BACKGROUND

In order that the educational programs and services of the Division may be conducted in the most effective and efficient manner, the Board will regularly review its existing and projected physical facilities.

The Education Act states that the Board may:

1. ~~Close a school permanently or for a specified period of time.~~
2. ~~Transfer all students from one school building to one or more other schools buildings on a permanent basis.~~

The Education Act states that a School Board may, only by resolution, permanently or temporarily

1. Close a school, or
2. Transfer students from one school building to another school building.

POLICY

The Board is responsible for providing educational programs and services in suitable facilities and for determining the number, kinds and locations of schools and programs to be established and maintained. The Board recognizes that under specific conditions it may be necessary to close a school, or portion thereof, due to fiscal constraints, enrolment, health and safety concerns and demographic changes. The Board further recognizes that, on occasion, programs may need to be closed or it may be necessary to relocate programs, grade levels or groups of students due to insufficient enrolment or financial or facility limitations.

GUIDELINES

1. ~~The Board will make every effort to keep all schools open in the jurisdiction. However,~~ The Board ~~may~~ **shall** consider closure **or relocation** of a school, program, **or** grade **reconfiguration**, ~~or a division within a school~~, when one or more of the following conditions exist.
 - 1.1. The student enrolment makes it difficult to provide resources for instructional programming.

- 1.2. The cost of keeping the school in operable condition or restoring it to operable condition is unreasonably high.
- 1.3. Keeping the school open poses a threat to the health or welfare of students, staff or the public.
- 1.4. There is a need to consolidate schools or relocate programs necessary to serve the overall interests of public education under the jurisdiction of the Board.
- 1.5. The utilization of facility is impacted upon by external factors.

~~2. The school closure process does not apply to the following conditions:~~

- ~~2.1. In connection with the transfer by one Board to another Board or to the operator of a charter school of the ownership of real property on which a school building is located and the school building will continue to be used for the instruction or accommodation of students,~~
- ~~2.2. As a result of the Minister's having directed the Board to dispose of the school building pursuant to section 200(3) of the Act, or~~
- ~~2.3. Pursuant to section 2(b) if:~~
 - ~~i. the school has more than one education program,~~
 - ~~ii. the students in the grades being closed are all in the same education program, and~~
 - ~~iii. the education program referred to in sub clause (ii) is to be transferred to another school.~~

2. The school closure process does not apply when the Minister directs a board to dispose of a school building pursuant to section 192 of the Education Act.

3. Where the Board determines that closure or relocation of a school, program, grade level or a group of students is to be considered pursuant to section (1)(c) above, the Board shall direct the Superintendent to initiate the appropriate school program closure or relocation process, as prescribed in legislation and the administrative procedures, with the school community.
