2. Early Childhood Services / MHPSD Service Delivery

Medicine Hat Public School Division offers a robust early learning program in our schools and in our community. We were given a look into the classrooms, parent engagement sessions and hear from some parents and partners to see early intervention in action.

Developing and preparing children for Grade 1 creates a solid foundation for future learning. Programs available include Community Early Learning Program (CELP), Early Learning Program (ELP), Kindergarten and Play and Learn. Early intervention supports provided allow the same service providers to support children in their early years through to graduation.

Language skills are developed and strengthened through play, both in person and virtually through the Hub. Occupational Therapists and their assistants help children to focus in the classroom using a variety of strategies. To ensure success of the child, both parents and staff are involved. Virtual programming developed during COVID has proven to be very useful and will be continued after the pandemic is over.
