VII. PRESENTATIONS

1. <u>Medicine Hat Public School Division Service</u> Delivery Model

Joanne Stockman provided an overview of the 2020-21 Service Delivery Model for ECS through Grade 12 and noted that funding changes have created a need for the Division to rethink how services are provided in schools.

The Division offers specialized learning supports through a 4-tier system, which includes collaboration, consultation, coaching and direct intervention. Services are being provided in the areas of speech and language, occupational therapy and physical therapy.

Speech and language service providers focus on communication through literacy support and language development. Occupational therapy centres around self-care, productivity/play and fine motor skills to support the development of a just right state for learning, while physical therapy addresses gross motor skills to support the development of balance, core strength, coordination, spatial awareness, muscle strength and ball skills.

2. <u>Human Resources Update</u>

Mr. Cunningham provided a Human Resources update to the Board.

The overview included information regarding stats on the hiring of teachers and educational assistants for 2020-21, online staff orientation and training sessions, performance management, occupational safetv health and training and program development, WCB Claim stats. disability management and health, wellness and attendance updates, in addition to the Division's response to COVID-19.

Mr. Cunningham also noted that MHPSD has been asked to participate in the ASEBP Short Term Disability Management pilot program commencing January 2021. This program will offer our Division further resources to assist with managing medical leaves during the 90-day elimination period prior to EDB.

VIII. <u>ITEMS FOR ACTION</u>

1. <u>Bylaw 2020-01 being a Bylaw to Establish</u> <u>Electoral Boundaries for Trustee General</u> <u>Election and Authority for a Joint Election</u>

Under the Education Act and the Local Authorities Act, a bylaw must be passed on or before December 31 of the year preceding the local election. The bylaw must be passed by three distinct and separate readings.

The Board was provided with a copy of Bylaw 2020-01. Mr. Labossiere noted that the Bylaw states that the Medicine Hat Public Board of Education declares that there shall be five (5) trustee positions and the election will be by general vote of the electors within the municipal boundaries of the City of Medicine Hat. In addition, the Board will authorize an agreement to hold a joint election in conjunction with the City of Medicine Hat and appoints the City of Medicine Hat's City Clerk to act as the Board's Returning Officer for the School Board Election on October 18, 2021.

The Secretary Treasurer presented the first reading of the bylaw, in its entirety, at the November 24th Regular meeting and trustees expressed their support of the bylaw.

Mr. Labossiere presented the second reading of the bylaw by title and description and Chair Wilson called for a vote. All trustees were in favour of the bylaw, as presented. The third and final reading of the bylaw was presented by title and description and Chair Wilson called for a vote. All trustees were in favour of the bylaw, as presented.

Mr. Labossiere declared that Bylaw 2020-01 has been enacted.

2. School Name Change

Administration recommended that the school name "YMCA Stay in School" (1239) be changed to "Pathways".

Superintendent Davidson noted that the way the outreach services have been used has changed significantly and the Division no longer has the same connection to the YMCA. Because of that, the Division would like to change the name to reflect the re-envisioned approach and to embody the work being done with the program.

A board resolution was required to change the school name.

THAT the school name **YMCA Stay in School** be changed to **Pathways**, as recommended.
